Each player will pay a \$75 fee. \$50 is the entry fee, \$3 will go towards the promotion fee, \$10 staff fee, and \$12 is the registration fee. 100% of all tournament promotion fees will be paid to the players in the Tournament Leader Board Promotion. The payments will be in the form of tournament entries or tournament entry chips.
- 5. **\$10 added to the prize pool for every entry that qualifies as a senior, (50 or older). \$400 maximum added to the prize pool.
