### Tournament Rules

1. Players start with 8,000 in tournament chips.
2. Blind levels last 20 minutes. Registration will be open through the 1<sup>st</sup> break. Players may re-enter during registration. Re-entries will be given a full stack.
3. Rules will be in effect for this event.
4. \$20 added for each military and first responder ID shown at registration (\$400 max).
5. Each player will pay a \$100 fee. \$70 is the entry fee, \$3 will go towards the promotion fee, \$10 staff fee, and \$17 is the registration fee. 100% of all tournament promotion fees will be paid to the players in the Tournament Leader Board Promotion. The payments will be in the form of tournament entries or tournament entry chips.
