Tournament Rules

1. Players start with 8,000 in tournament chips.
2. Players will receive 2,000 in tournament chips for an optional \$10 dealer appreciation.
3. Blind levels last 20 minutes. Registration will be open for the first 3 levels. Players may re-enter during registration.
4. TDA Rules will be in effect for this event.
5. Each player will pay a \$140 fee. \$117 is the entry fee, \$3 will go towards the promotion fee, and \$20 is the registration fee.
6. 100% of all tournament promotion fees will be paid to the players in the Tournament Leader Board Promotion. The payments will be in the form of tournament entries or tournament entry chips.
7. **This event will not occur on the weekend of the \$50,000 Guaranteed Tournament or the \$10,000 guarantee tournament.** This tournament will have a guaranteed prize pool of \$5,000. In the event the prize pool does not reach \$5,000, the difference will be added from the Beau Rivage Poker Room Promotion Fund.
