Tournament Rules

1. Players start with 10,000 in tournament chips.
2. Blind levels last 20 minutes. Registration will be open through the 1st break. Players may re-enter during registration. Re-entries will be given a full stack.
3. TDA Rules will be in effect for this event.
4. Each player will pay a \$100 fee. \$70 is the entry fee, \$3 will go towards the promotion fee, \$10 staff fee, and \$17 is the registration fee. 100% of all tournament promotion fees will be paid to the players in the Tournament Leader Board Promotion. The payments will be in the form of tournament entries or tournament entry chips.
5. *\$20 added to the prize pool for every entry that qualifies as a senior, (50 or older). \$400 maximum added to the prize pool.
