Tournament Rules

1. Players start with 10,000 in tournament chips.
2. Blind levels last 20 minutes. Registration will be open through the 1st break. Players may re-enter during registration. Re-entries will be given a full stack.
3. TDA rules will be in effect for this event.
4. Each player will pay a \$100 fee. \$70 is the entry fee, \$3 will go towards the promotion fee and \$27 are administrative fees.
5. Seating may be limited. A minimum of 3 tables will be dedicated to this event.
6. This event will allow for a max of 50 entries.
7. Hybrid blind format. Big Blind Ante through level 10. Conventional ante level 11 and up.
